

**CIRCULAR INVITING OBJECTIONS TO SENIORITY OF INSPECTORS AS  
ON 01.04.2005**

Hon'ble Central Administrative Tribunal Jammu Bench has passed a judgement on 26.03.2025 in the case bearing TA No.: 6424/ 2020 titled Ajay Kumar & Ors vs State of J&K & Ors. The operative part of the aforesaid judgement under para 16 reads as:

*"In light of the aforementioned findings, this Tribunal concludes that the promotions of respondents No. 5 to 9 as Inspectors and their subsequent confirmation on a retrospective basis were illegal and contrary to the J&K Weights and Measures Subordinate Service Recruitment Rules, 1978. Consequently, the following reliefs are granted:*

i) *The order bearing No. WM-88/01 dated 13.2.2001 whereby respondent No. 5 was confirmed in the pay scale of Rs. 5700 10100 as Inspector is hereby quashed.*

ii) *The order bearing No. WM/C/Estt/2004 dated 01.07.2004 whereby respondent No. 6 was confirmed as an Inspector is hereby quashed.*

iii) *The order bearing No. 218-WM/2004 dated 09.09.2004 whereby respondent No. 6 was confirmed as Inspector with retrospective effect from 15.12.2000 is hereby quashed.*


iv) *The order bearing No. 126/APD/05 dated 11.04.2005, issued by respondent No. 2, whereby respondents No. 5 and 6 were promoted as Assistant Controllers in the pay scale of Rs. 7500-12000 is also quashed.*


v) *The respondents No. 1 to 4 are directed to prepare the seniority list of Inspectors strictly in accordance with the recruitment rules and ensure that the petitioners are assigned seniority above respondents No. 5 to 9 in view of their valid appointment under the direct recruitment quota. The respondents are directed to consider the petitioners for promotion to the post of Assistant Controller strictly on the basis of their legitimate seniority. The whole exercise shall be completed in an expedite manner in any event not later than eight weeks from the date of receipt of this judgment."*

Para 17 of the aforesaid judgement reads as:




